# DESK FOR PROTECTION OF RIGHTS AND SUPPORT FOR FOREIGN COMMUNITIES IN F.V.G

ANOLF, based on the experiences gained in twenty years of activity, provides the following orientation and social inclusion services in the regional territory. The fundamental objective of the desk is to network and collaborate with services municipal territories in order to provide correct information and be able to direct users to the competent service.

## CONSULTANCY AND SUPPORT

### To the communities

- Promote Italian language and culture courses as well as civic education and citizenship for communities in particular for foreign mothers/women
- Promote meetings on the new features of Model 730 and ISEE 2024 to prepare the necessary documents
- Support in filling out the financial support application form
- Support on the recognition in Italy of qualifications obtained abroad
- Accompanying service at local institutions
- Administrative support for attending study courses (support services for the right to study)
- Support to facilitate foreign prisoners in resolving their integration problems, in the appropriate offices of the prison in the region

### Health information

- What does registration with the National Health Service entitle you to?
- Urgent or essential outpatient and hospital care, even if continuous, for illness and injury
- Protection of pregnancy and maternity
- Protection of the minor's health
- Vaccinations required by national legislation and as part of collective prevention interventions authorized by the Region
- Request for a general practitioner, vaccines, how to obtain/renew the health card, reservations for ASUGI visits, affiliated hospital and private centers

### Job information

- Employment center / employment agencies / CV / skills assessment / union protection
- Advice and support to entrepreneurs in issuing entry visas and in managing the employment of foreign citizens; issuing of entry visa for: self-employment and management of stay for work in particular cases art. 27, for hiring and family/domestic assistance
- Procedures for moving to another EU country

### Home information

- House for rent / lease

### School information

- Enrollment in CPIA, high schools and universities or in another course of study

### Information on citizen service

- Municipal services, INPS, banking services, postal services, SPID and CIE

## RIGHTS PROTECTION SERVICE

### Legal assistance in: immigration, civil and criminal areas

- Assistance and representation in proceedings before ordinary and administrative judicial bodies
- Preparation of LEGAL MEMORIES (notice of rejection pursuant to art. 10 bis Law 241/90) at the relevant bodies
- Advice and assistance in problems of both a civil nature (compensation for damages, separations and divorces, etc.) and of a criminal nature, with particular reference to problems connected to the penitentiary stay of a family member
- Consultancy and assistance in relations with the various Italian consular representations abroad regarding legalization and issuing of special powers of attorney
- What to do in case of denial of: request for citizenship, visa, residence permit
- What happens if the consular authority does not issue the aforementioned marriage permit?
- How does the case of acquisition of Italian citizenship by the direct descendants of an Italian citizen work?
